## ORDER DENYING HUMANA'S MOTION TO COMPEL REORGANIZED DEBTORS TO COMPLY WITH COURT ORDER

This addresses Humana's Motion to Compel Reorganized Debtors to Comply with Court Order (Docket Entry No. 3516, the "Motion"), filed by Humana Insurance Company and Human Health Plan, Inc.
