## STIPULATION BETWEEN THE DCHC LIQUIDATING TRUST AND CONTECH-MSI RESOLVING THE TRUST'S OBJECTION TO CONTECH-MSI'S CLAIM

Contech-MSI must provide The DCHC Liquidating Trust with a fully executed W-9 Form before the Trust pays the Claim.

The DCHC Liquidating Trust's objection and request to disallow the Claim, dated October 2, 2008 [Docket No. 3472], shall be deemed fully resolved, subject to the terms of this Stipulation.

Nothing contained herein shall be deemed to affect any post-petition administrative expense claim that Contech-MSI may have, including \$3,912.75 in what DCHC Liquidating Trust contends is post-petition retainage asserted in Contech-MSI's Invoice No. 80420 dated March 20, 2003, and \$87,522.65 for post-petition work performed for quarter smoke and fire detection supplies, annual smoke and fire detection testing, annual fire-prep testing, fail-safe lock release, and miscellaneous work related to Michael Reese Medical Center Corporation's premises.
