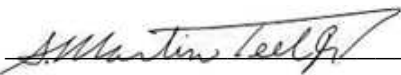

**ORDER GRANTING MOTION OF THE DCHC LIQUIDATING TRUST
SEEKING AMENDMENT OF ORDER CONCERNING IRS W-9 FORMS AND
REDISTRIBUTION OF FUNDS FROM NONRESPONDING CLASS 8 AND 10
CREDITORS TO RESPONDING CLASS 8 AND 10 CREDITORS (DOCKET NO. 3496)**

Upon consideration of the Motion of The DCHC Liquidating Trust (the "Trust") Seeking to Amend an Order of this Court entered on October 27, 2008 [Docket No. 3496] (the "Motion"),

It is **HEREBY ORDERED THAT:**

1. The relief requested in the Motion is GRANTED.
2. The Order Establishing Procedures and Deadlines Concerning IRS W-9 Forms and Redistribution of Funds from Nonresponding Creditors, entered by this Court on October 29, 2008 (the "W-9 Procedures Order") [Docket No. 3496], is hereby

amended to remove all references that make the W-9 Procedures¹ applicable only to each holder of an allowed claim (or allowed claims in the aggregate) of \$600 or more.

3. The W-9 Procedures Order is hereby clarified to apply the W-9 Procedures to all Claimholders.
4. The Trust is authorized to send W-9 Letters (and W-9 Form), in substantially the form attached hereto as Exhibit B, to each claimholder listed on Exhibit A hereto (each a holder of an allowed claim (or allowed claims in the aggregate) of less than \$600). The claimholders listed on Exhibit A hereto will have 60 days from the date the W-9 Letters are sent to complete and submit the W-9 Form. The W-9 Procedures Order, including the W-9 submission deadline for claimholders holding allowed claims of \$600 or more, will otherwise remain unmodified.
