

**ORDER GRANTING DEBTORS' APPLICATION FOR ORDER AUTHORIZING THE

NOTICE AGENT AND CLAIMS AGENT FOR THE DEBTORS**

This matter coming to be heard upon the above captioned debtors and debtors in possession (collectively, the "Debtors") Application for Order Authorizing the Employment and Retention of Poorman-Douglas Corporation ("Poorman") as Notice Agent and Claims Agent for the Debtors (the "Application"),<sup>2</sup> the Debtors having filed petitions for relief under chapter 11 of

the Bankruptcy Code on the Petition Date; and upon the affidavit of Paul Meade, Senior Vice President of Poorman (the "Affidavit") dated May 12, 2004; and the Court being satisfied, based on the representations made in the Application and the Affidavit, that Poorman represents no interest adverse to the Debtors' estates with respect to matters upon which it is to be engaged, that Poorman is a "disinterested person" as that term is defined under Section 101(14) of the Bankruptcy Code, and that the employment of Poorman is necessary and would be in the best interests of the Debtors, their creditors and the Debtors' estates; and after due deliberation and sufficient cause appearing therefor,

**IT IS HEREBY ORDERED** that:

1. The Debtors' request for employment and retention of Poorman as notice agent and claims agent for the Debtors in these chapter 11 cases is hereby granted in accordance with the terms outlined in the Application as modified herein.
2. Simultaneously with providing the Debtor with its invoices as required in the Poorman Agreement, Poorman shall mail copies of its invoices to the Office of the United States Trustee, the Official Committee of Unsecured Creditors, if formed, and the agent to Debtors' prepetition secured lenders and DIP lenders. If no objection is received to the invoice within 15 days after the mailing thereof, the Debtors shall be authorized to pay such invoices, in accordance with the Poorman Agreement. If an objection is made to some or all of any Poorman invoice, Poorman may file a motion with the Court for approval of payment of amounts owing under such invoices.
3. All notices sent by Poorman on behalf of the Court must be approved by the Office of the Clerk for this Court.
4. All Proofs of Claim filed in these cases shall be filed with the Clerk for this Court who shall retain all original Proofs of Claim and forward copies of each and every Proof of

Claim to Poorman.

5. This Court retains jurisdiction with respect to all matters arising from or related to the implementation of this Order.

6. This Order is effective immediately upon its entry.
