
To Whom It May Concern:

Please be advised that this letter will serve as written notice that Advanced Assembly Automation is in default of the lease between CityWide Development Corporation and Advanced Assembly Automation dated February 20, 1996, as amended, and further is in default of the lease between CityWide Development Corporation and Advanced Assembly Automation dated March 5, 1999. The default is due to nonpayment of rent and nonpayment of real estate taxes as required by the respective leases.

With respect to the lease dated February 20, 1996, as amended, you are in default for failure to pay real estate taxes as required by paragraph 15 in the amount of \$34,222.60. You are further in default of the lease dated February 20, 1996, as amended, for failure to pay rent for February, March and April, 2004 in the aggregate sum of \$158,609.25. Be reminded that the May rent will be due May 1, 2004.

With respect to the lease dated March 5, 1999, paragraph 15 requires you to pay real estate taxes and you are in default of that obligation in the amount of \$7,461.29. You are also in default for failure to pay rent for the months of February, March, and April, 2004 in the aggregate sum of \$74,864.97. Please be advised that the May 2004 rent payment will be May 1, 2004.
