**AGREED ORDER
ORDER AUTHORIZING THE REJECTION OF UNEXPIRED
NON-RESIDENTIAL REAL PROPERTY LEASE**

This matter coming before the Court seeking entry of an order authorizing the Debtor to reject and approving such rejection, *nunc pro tunc* to September 21, 2012 (the “Petition Date”), that certain Lease Agreement by and between WEP Land Holdings, LLC, as predecessor-in-interest to Cole DI Yukon OK, LLC (“Cole”), as landlord, and Dickinson Theatres, Inc. (the “Debtor”), as tenant, dated August 29, 2006, as assigned and assumed by Yukon Cinemas LLC (“Yukon”) pursuant to that certain Assignment and Assumption of Lease dated August 30, 2007 by and between Cole, the Debtor and Yukon and further assigned and assumed by Showplex Cinemas, Inc. (“Showplex”) pursuant to that certain Assignment, Assumption and Consent

Agreement dated as of November 15, 2011 by and among Cole, the Debtor and Showplex (as assigned and assumed, the "Lease Agreement") and finding that the Debtor has no interest in the Lease Agreement; it appearing that the relief agreed to by the Debtor and Cole is in the best interests of the Debtor's estate, its creditors and other parties-in-interest, and pursuant to the agreement between the parties, after due deliberation and sufficient cause appearing therefore, it is hereby

ORDERED that the Debtor is authorized to reject, *nunc pro tunc* to the Petition Date the Lease Agreement and that the Debtor has no interest in the Lease Agreement; and it is further

ORDERED that such rejection is hereby approved; and it is further

ORDERED that Cole shall not file any further claims against the Debtor on account of this Order and has no rejection damages as a result of this Order permitting Debtor to reject the Lease Agreement, *nunc pro tunc*;
