**ORDER SUSTAINING DEBTOR'S OBJECTION TO CLAIM #45  
FILED BY METROPOLITAN FIRE EXTINGUISHER COMPANY, INC.,  
TRANSFERRED TO DEBT ACQUISITION CO. OF AMERICA V, LLC AS  
CLAIM #45 HAS BEEN SATISFIED IN FULL POST-PETITION**

Upon the Objection filed by Dickinson Theatres, Inc. ("Debtor"), to Claim #45 of Metropolitan Fire Extinguisher Company, Inc., Transferred to Debt Acquisition Co. of America V, LLC ("Claimant") in the case of Dickinson Theatres, Inc., Case No. 12-22602, this matter comes on before this Court.
