**ORDER SUSTAINING DEBTOR'S OBJECTION TO CLAIM #65
FILED BY GG&A CENTRAL MALL PARTNERS LP AS
CLAIM #65 HAS BEEN SATISFIED IN FULL POST-PETITION**

Upon the Objection filed by Dickinson Theatres, Inc. ("Debtor"), to Claim #65 of GG&A Central Mall Partners LP ("Claimant") in the case of Dickinson Theatres, Inc., Case No. 12-22602, this matter comes on before this Court.
