**ORDER SUSTAINING DEBTOR'S OBJECTION TO CLAIM #80
FILED BY SUNBELT LANDSCAPE MANAGEMENT AS
CLAIM #80 HAS BEEN SATISFIED IN FULL POST-PETITION**

Upon the Objection filed by Dickinson Theatres, Inc. ("Debtor"), to Claim #80 of Sunbelt Landscape Management ("Claimant") in the case of Dickinson Theatres, Inc., Case No. 12-22602, this matter comes on before this Court.
