**MOTION TO EXPEDITE HEARING ON APPLICATION FOR ORDER UNDER 28
U.S.C. § 156(c) AUTHORIZING THE RETENTION OF THE BMC GROUP, INC. AS
NOTICE AND CLAIMS AGENT FOR THE TRUSTEE**

James A. Knauer, as chapter 11 trustee for the Debtor, Eastern Livestock Co., LLC ("Trustee"), by counsel, hereby moves the Court ("Motion") for an order setting an expedited hearing on the *Application For Order Under 28 U.S.C. § 156(C) Authorizing The Retention Of The BMC Group, Inc. As Notice And Claims Agent For The Trustee* ("Application") (docket #320) filed by the Trustee on March 8, 2011. The Trustee requests entry of an order appointing BMC¹ as his claims agent in this Chapter 11 Case on an expedited basis. The Trustee requests that the Court set the Application for an immediate hearing on March 11, 2011 at 9:30 a.m. EST on shortened notice due to the heavy administrative and other burdens imposed on the Court and the Clerk's Office because of the numerous creditors and other parties in interest involved in the Debtor's Chapter 11 Case.

As explained in the Application, the Trustee requests that this Court enter an order under 28 U.S.C. § 156(c) and Local Rule B-1007-2 appointing BMC as his claims agent in this Chapter 11 Case in order to handle the volume involved in properly processing the claims of creditors and other interested parties in this Chapter 11 Case.

2. No party will be harmed by providing the relief requested on an expedited basis and such relief will benefit all creditors.

WHEREFORE, the Trustee respectfully requests that the Court enter an Order (1) setting the Application for a hearing on March 11, 2011 at 9:30 a.m. EST, (2) shortening notice thereon, and (3) granting the Trustee such other and further relief as is just and proper.
