

We are reflecting for the first time this month an account at First Merchants Bank. This account was set up to isolate, per a settlement agreement, a remittance from SOLM related to contracts. We are also restating the accounts receivable balances. Balances as restated exclude invoices for which payments were diverted by ELC employees and transactions which are believed to be fraudulent.

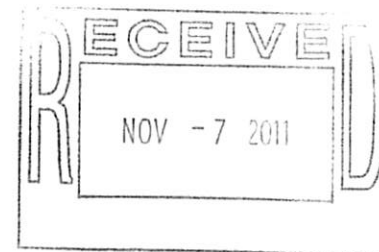

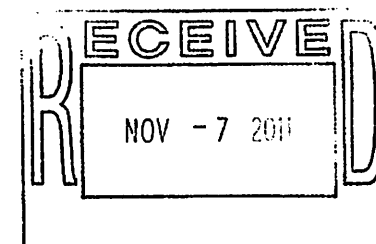
