**MOTION FOR EXTENSION OF TIME TO OBJECT TO DISCHARGE  
AND DISCHARGEABILITY OF DEBT PURSUANT TO 11 U.S.C.  
SECTION 523 AND/OR 11 U.S.C. SECTION 727**

Section 523 and/or 11 U.S.C. Section 727, and as grounds therefore states:

1. On March 31, 2008, the Debtor filed his Voluntary Petition under Chapter 7 of the United States Bankruptcy code.
2. The Section 341 Meeting of Creditors has been scheduled for three separate occasions and the Debtor has failed to appear.
3. The Court entered an omnibus order (CP# 75) extending all deadlines for objections to discharge or exceptions to discharge to December 29, 2008.
