

**AGREED ORDER SUSTAINING-IN-PART AND OVERRULING-IN-PART  
TRUSTEE'S OBJECTION TO CLAIM OF PRIMUS GMBH (CLAIM NUMBER 443) AS  
TO CERTAIN INDIVIDUAL INVESTORS**

**THIS CAUSE** came before the Court on August 12, 2015 at 11:00 a.m. upon the *Trustee's Objection to Claim of Primus GMBH [Claim Number 443]* [ECF No. 1057] (the "Objection") and the *Response to Trustee's Objections (Doc. 1057) to Proof of Claim Number 443 Filed in the Engler Bankruptcy Case* [ECF No. 1080] (the "Response") filed by certain individual investors who filed Proof of Claim Number 443 (collectively, the "Group Claimants"). The Court, having considered the Objection and the Response, finding that service of the Objection was proper under Bankruptcy Rule 3007 and Local Bankruptcy Rule 3007-1(b),

and noting the agreement of the parties to treat the claims of certain of the Group Claimants as set forth on the attached Exhibit "A." Accordingly, the Court **ORDERS and ADJUDGES** as follows:

1. The Objection as to those Group Claimants on the attached Exhibit "A" is **SUSTAINED-IN-PART** and **OVERRULED-IN-PART** as set forth herein.

2. Each individual claim of the Group Claimants listed on Exhibit "A" is hereby allowed, disallowed or allowed at a reduced amount in the manner set forth on Exhibit "A."

3. The Court reserves jurisdiction to enforce the terms of this order.
