## ORDER GRANTING FIDELITY NATIONAL RANCH PROPERTY'S MOTION FOR RELIEF FROM OR MODIFICATION OF AUTOMATIC STAY (DOC. 99)

This matter came on for hearing on January 23, 2009, on Fidelity National Ranch Property's Motion for Relief From or Modification of Automatic Stay (Doc. 99) ("Motion for Relief"), this Court having heard argument from counsel for Robert Tardiff, the Debtor's Chapter 7 Trustee ("Trustee") and from counsel for Fidelity National Financial, Fidelity National Timber Resources, Inc. f/k/a Fidelity National Ranch Properties, Inc. ("Fidelity National"), this Court having reviewed the Motion for Relief as well as the Trustee's Response in Compliance With Order Directing Response to Motion for Relief From Stay Filed by Fidelity National Ranch Property (Doc. 106), this Court having reviewed other pleadings and papers filed in the Debtor's case and this Court being otherwise fully advised in the premises, it is hereupon ORDERED and ADJUDGED as follows:

- The **Motion for Relief** is hereby **GRANTED**, to the extent set forth herein; and 1.
- 2. Fidelity National is hereby permitted to proceed with whatever state court litigation rights it has in either quieting title on its Installment Land Sales Contract, dated November 9, 2006, or by pursuing a judicial or non-judicial foreclosure of its rights with respect to the subject property, all of which may be pursued up to the point of entry of a Final Judgment entered by a court of competent jurisdiction; and

3. In the event Fidelity National forecloses its interest in the subject property by obtaining a Final Judgment of foreclosure, it may only set a foreclosure sale following the entry of an additional order by this Court permitting the scheduling of such a sale.
