**RESPONSE TO TRUSTEE’S TENTH OMNIBUS OBJECTION TO CLAIMS:
CLAIM NO. 895 – TCA TRADING & CONSULTING AG**

Claimant TCA TRADING & CONSULTING AG, whose Claim has been assigned **Claim No. 895**, responds to the Trustee’s Tenth Omnibus Objection to Claims as follows:

1. Claimant TCA TRADING & CONSULTING AG disputes the “Amount Received as Return of Principal or Interest Payment” claimed by the Trustee in the amount of \$104,700.00, and claims that the actual amount received was \$102,000.00.

2. As such, the amount of the Proposed Allowed Claim should be **\$98,000.00**, calculated as follows:

\$200,000.00	\$284,000.00	\$102,000.00	\$ 84,000.00	\$98,000.00

Relief Requested

Claimant TCA TRADING & CONSULTING AG requests that the “Amount Received” be corrected to reflect the amount of \$102,000.00 as opposed to the Trustee’s Amount of \$104,700.00, such that the Allowed Claim be calculated as **\$98,000.00**.
