**RESPONSE TO TRUSTEE’S THIRD OMNIBUS OBJECTION TO CLAIMS:  
CLAIM NO. 896 – CORNELIA FASSOLD**

Claimant CORNELIA FASSOLD, whose Claim has been assigned **Claim No. 896**, responds to the Trustee’s Third Omnibus Objection to Claims as follows:

1. Claimant FASSOLD disputes the “Amount Received as Return of Principal or Interest Payment” claimed by the Trustee in the amount of \$1,603.40, and claims that the actual amount received was \$0.00.

2. As such, the amount of the Proposed Allowed Claim should be **\$5,000.00**, calculated as follows:

**Relief Requested**

Claimant CORNELIA FASSOLD requests that the “Amount Received” be corrected to reflect the amount of \$0.00 as opposed to the Trustee’s Amount of \$1,603.40, such that the Allowed Claim be calculated as **\$5,000.00**.
