**CERTIFICATE OF NO RESPONSE OR  
SETTLEMENT AND REQUEST FOR ENTRY OF ORDER**

Pursuant to Fed.R.Bankr.P. Rule 3007, ROBERT E. TARDIF, JR. (the “Trustee”), as Chapter 7 Trustee for the substantively consolidated bankruptcy estates of Ulrich Felix Anton Engler (“Engler”), Private Commercial Office, Inc. (“PCO”), and PCO Client Management, Inc. (“PCOM”) (collectively, the “Debtors”), filed his Eleventh Omnibus Objection to Claims (Claimant Names Beginning with “W”, “X”, “Y” & “Z”) [ECF No. 1140] on August 19, 2015 (the “Objection”). The Trustee hereby respectfully represents:

1. The Trustee timely served the Objection on all interested parties pursuant to the referenced rule as is shown on the certificate of service previously filed for the Objection [ECF No. 1154].
2. The Objection contained the bulletin required by the referenced rule.
3. The deadline for response to the Objection was October 21, 2015.
4. No responses to the Objection have been received as of November 16, 2015 except as set forth below.
5. A check of the electronic entries docketed in these cases confirms that no

responses or requests for hearing have been filed, except as follows: (i) the Trustee has received a Notice of No Opposition to the Objection from Renate & Florian Zink [ECF No. 1270], Hans-Henning Wilke [ECF No. 1225], Sebastian Wilke [ECF No. 1255] and Axel Walter [ECF No. 1231]; (ii) the Trustee has received an informal notice of no opposition for counsel Klaus Wolfschmidt (Claim Number 48); and (iii) the Trustee and counsel for certain group claimants have agreed that the individual claims of Eduard Wildburger (Claim Numbers 749, 750, 751 and 752) shall be included within certain group claims and that the individual claims should be stricken and disallowed. To the extent necessary, the Trustee's objections to such claims are resolved by agreement in the order uploaded herewith.

**WHEREFORE**, the Trustee seeks the entry of an Order granting the relief sought in the Objection in the form uploaded to CM/ECF simultaneously herewith.
