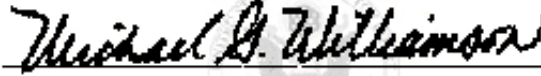

**ORDER SUSTAINING-IN-PART AND OVERRULING-IN-PART
TRUSTEE'S SIXTH OMNIBUS OBJECTION TO CLAIMS
