SUPPLEMENT TO AMENDED JOINT MOTION FOR TURNOVER OF UNDISTRIBUTED BANKRUPTCY ESTATE FUNDS FROM LAW FIRM OF URBAN THEIR FEDERER & CHINNERY, P.A. (DOC. 1630)

The Unsecured Creditors whose claims are reflected in the group of claims filed as part of proofs of claim numbered 69, 444 and 493 (the "Claimants" or "Claimant Group"), are a group of certain individual creditors¹ who own and hold claims filed on their behalf by Ulrich Messmer ("Messmer") in the above-captioned bankruptcy case hereby files this *Supplement to Amended Joint Motion for Turnover of Undistributed Bankruptcy Estate Funds*, against Urban Their Federer & Chinnery, P.A. ("Urban Firm"). In support, the Claimant Group states as follows:

1. In paragraphs 25-27 of the *Amended Joint Motion for Turnover of Undistributed Bankruptcy Estate Funds ("Motion")*, the Claimants identified the following distributions by the Trustee: (1) a September 14, 2017, check issued by the Trustee made payable to Ulrich Messmer in the amount of \$2,255,998.94 on account of Claim No. 69; (2) September 15, 2017, check issued by the Trustee made payable Ulrich Messmer in the amount of \$32,551.36 on account of

Claim No. 444; and (3) a September 15, 2017 check issued by the Trustee made payable to Ulrich Messmer in the amount of \$90,770.89 on account of Claim No. 493.

2. Upon receipt of the checks, but without the consent of the actual holders of claims, the claim distribution checks made payable to Messmer were delivered to a lawyer named John L. Urban ("Urban"), the founding shareholder of the Urban Firm and the managing shareholder of its Orlando, Florida office.

3. In addition to those funds identified above and in the Motion, the following payments were distributed by the Trustee: (1) a September 14, 2017 check made payable to Hima AG in the amount of \$197,546.02 on account of Claim No. 64; (2) a September 14, 2017 check made payable to Mantel & Partner in the amount of \$171,950.16 on account of Claim No. 65; (3) a September 14, 2017 check made payable to Congro Finanz AG and Primus GmbH in the amount of \$124,590.50 on account of Claim No. 66; (4) a September 14, 2017 check made payable to Primus GmbH in the amount of \$995,300.48 on account of Claim No. 67; (5) a September 14, 2017 check made payable to Congro Finanz AG in the amount of \$839,749.96 on account of Claim No. 68; and (6) a September 14, 2017 check made payable to Primus GmbH in the amount of \$16,773.57 on account of Claim No. Claim No. 443.
