ORDER DENYING MOTION FOR UNCLAIMED FUNDS

□ Claimant's name, address and telephone number were not provided.

 \square No explanation of the right of the claimant to the unclaimed funds was provided.

□ The Movant did not supply a notarized original Power of Attorney.

 \Box The Corporate claimant failed to provide a corporate power of attorney signed by an officer of the company and a statement of the signing officer's authority.

 \Box The Movant did not supply a certified copy of the decedent's death certificate and/or certified copies of all probate documents that substantiate the right to act on behalf of the decedent's estate.

 \Box The Movant did not supply sufficient documentation evidencing the transfer of the claim or proof of purchase/sale of the assets.

 \blacksquare The amount of funds requested does not match the amount held in the court registry.

 \square There are no funds on deposit in the name of the movant.

Accordingly, it is

ORDERED:

That the Motion for Payment of Unclaimed Funds filed by Darrin R. Schutt, Esq., on behalf of Anneliese Faessler, \$4,220.48 is denied.
