

(collectively the "defendants"), at the time of the answer or was indebted at the time of service of the writ, or at any time between such times, and in what sum and what tangible or intangible personal property of the defendant the garnishee is in possession or control of at the time of the answer or had at the time of service of this writ, or at any time between such times, and whether the garnishee knows of any other person indebted to the defendant or who may be in possession or control of any of the property of the defendant. The amount set in plaintiff's motion is \$3,957,427.30, not including accrued interest.
