**ORDER GRANTING TRUSTEE'S MOTION TO APPROVE
SECOND OMNIBUS MOTION TO APPROVE COMPROMISE OF CONTROVERSIES**

THIS CAUSE came before the Court upon the Second Omnibus Motion To Approve Compromise Of Controversies filed by ROBERT E. TARDIF, JR., as Trustee for the Chapter 7 Bankruptcy Estates of Ulrich Felix Anton Engler, Private Commercial Office, Inc. and PCO Client Management, Inc. (hereinafter the "Trustee") [D.E. 465] (the "Motion"). The Court, having noted that the Motion was served on creditors and parties in interest pursuant to Local Rule 2004²/₄(a)(5) and that no objections were filed, pursuant to Fed. Bankr. R. P. 9019, finds that the settlements and compromises contained in the Motion are reasonable and in the best interests of the creditors and the estate, and being otherwise fully advised in the premises, it is hereby,

ORDERED, as follows:

1. The Trustee's Motion is GRANTED.
2. The compromise and settlement between the Trustee and Defendants as listed in Exhibit "A" of the Motion are hereby approved subject to satisfaction of the conditions subsequent set forth therein.

3. The parties are hereby ordered to comply with the terms of the compromise and settlement and authorized to take all actions necessary and appropriate to the consummate the transactions contemplated thereby.

4. The Court reserves jurisdiction to enforce the terms of the settlements set forth in Exhibit "A" of the Motion and approved by this Order.
