Adversary Case No. 9:10-ap-0518 against Heinrich Lohmann and Adversary Case No. 9:10-ap-0539 against Christian Brey were previously dismissed and the Trustee is not required to take any further formal action with respect to these adversary proceedings following receipt of the settlement funds.
