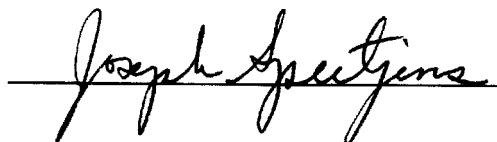

**ORDER GRANTING TRUSTEE'S MOTION FOR TURNOVER OF
PAYMENTS OWED TO THE BANKRUPTCY ESTATE**

(the "Motion for Turnover") filed by Robert E. Tardif, Jr. (the "Trustee"), as Chapter 7 Trustee
of the substantively consolidated bankruptcy estates of Ulrich Felix Anton Engler, Private
Commercial Office, Inc., and PCO Client Management, Inc. (collectively, the "Debtors"). The
Court having reviewed the Motion for Turnover, heard from counsel for the parties, been
apprised of their agreement to entry of this Order, ^{and} ~~being~~ otherwise duly advised in the premises,
~~and for the reasons stated orally and recorded in open Court, which shall constitute the decision of this~~
^{and} ~~Court~~, does hereby

ORDER as follows:

1. The Trustee's Motion for Turnover is GRANTED. AUTOQUEST OF SOUTHWEST FLORIDA, INC. ("Autoquest") shall turnover loan proceeds in the aggregate amount of Four Hundred Ninety Thousand and 00/100 Dollars (\$490,000.00) to the Debtors' bankruptcy estate pursuant to 11 U.S.C. § 542(b) within thirty (30) days of the date of entry of this Order (the "Loan Proceeds").

2. In the event Autoquest fails to turnover the Loan Proceeds to the Debtor's bankruptcy estate within thirty (30) days of the date of entry of this Order, the Trustee shall be entitled to pursue any legal or equitable relief that may be available with the exception of a judgment for the Loan Proceeds because the Loan Proceeds are included in the Final Judgment entered in the adversary proceeding styled *Robert E. Tardif, Jr., Chapter 7 Trustee v. Autoquest of Southwest Florida, Inc., et al.*, United States Bankruptcy Court for the Middle District of Florida, Case No. 9:10-ap-00435-MGW.

3. The Court reserves jurisdiction over this matter and the parties hereto to enter any other and further orders for relief as may be appropriate.
