**MOTION FOR AUTHORITY TO SELL PROPERTY  
OF THE ESTATE FREE AND CLEAR OF LIENS**

COMES NOW the Trustee in the above-styled case, ROBERT E. TARDIF JR., and hereby moves this Court for authority to sell property of the estate free and clear of liens, and as grounds therefore states as follows:

1. Trustee proposes to sell the following property described below pursuant to 11 U.S.C. § 363: Unit 203, Building B, Phase 1, The Porches of Deep Creek I (1462 Rio De Janeiro Avenue, Unit B-203, Punta Gorda, Florida.)
2. The proposed purchaser is Allen Libby, or his assigns.
3. The selling price is \$15,000.00. The Trustee retained a real estate broker/agent to market. In addition, the property has been inspected and Chinese Drywall was found.
4. Trustee is informed that the following creditors may have liens upon the property:

**NOTICE OF OPPORTUNITY TO OBJECT AND FOR HEARING**

Pursuant to Local Rule 2002-4, the Court will consider this motion, objection or other matter without further notice or hearing unless a party in interest files an objection within 21 days from the date of service of this paper. If you object to the relief requested in this paper, you must file your objection with the Clerk of the Court at Sam M. Gibbons United States Courthouse, 801 N. Florida Avenue, Suite 555, Tampa, Florida 33602 and serve a copy on Robert E. Tardif Jr., Trustee, Post Office Box 2140, Fort Myers, FL 33902, and on the Assistant United States Trustee, 501 E. Polk Street, Suite 1200, Tampa, Florida 33602.

If you file and serve an objection within the time permitted, the Court will schedule a hearing and you will be notified. If you do not file an objection within the time permitted, the Court will consider that you do not oppose the granting of the relief requested in the paper and will proceed to consider the paper without further notice or hearing and may grant the relief requested.

5. The Trustee proposes to pay the following liens and expenses from the proceeds of sale to enable him to sell the property free and clear of liens:
  - a. Bonnie Hemenway (Coldwell Banker and Cooperating Broker, if any) \$1,500.00
  - b. Other reasonable and customary closing costs to the Trustee, as Seller, including the following:

i.	Title search and settlement fee	\$351.25
ii.	Documentary Stamps (\$0.70 per \$100.00 of sale amount)	\$105.00
iii.	Condo Assessments of approximately	\$2,056.00
iv.	Back taxes and prorated taxes and garbage of approximately	\$5,792.14
v.	Property Management liens through 11/1/10	\$2,019.09
vi.	Late Fees (at \$25.00/month) of approximately	\$200.00
vii.	Reasonable and customary closing costs not to exceed	\$400.00

6. The Trustee intends that the purported liens of creditors not identified as being paid in Paragraph 5 shall be transferred to and shall have the same priority, if any, to the proceeds of the sale.
  
7. The Trustee will entertain any higher bids for the purchase of the property that the Trustee proposes to sell. Such bids must be in writing and accompanied by a cashier's check payable to Robert E. Tardif Jr., Trustee in Bankruptcy in the Bankruptcy of ULRICH FELIX ANTON ENGLER, in the amount of 10% of the proposed higher purchase price. **The Trustee must receive any higher bids at the Trustee's address listed below no later than 5 p.m. on July 11, 2011.** Trustee will then call the three highest bidders (in addition to the original bidder named above), and make arrangements to conduct an auction with those parties, either telephonically, or in person, at the discretion of the Trustee. In the event the Trustee accepts a higher bid, the purchaser in the Order of Sale shall be the highest bidder at the price and terms accepted by the Trustee.

WHEREFORE the Trustee moves the Court for entry of an Order authorizing the sale of the above-described property free and clear of liens in accordance with the terms stated herein.
