

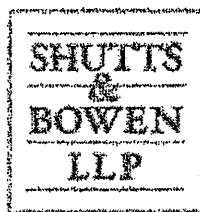

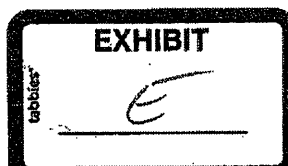

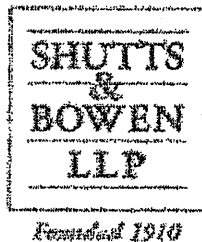

The court awarded special counsel fees of \$3,500 but the court gave SunTrust only until today to produce the documents, and I suppose there could be more sanctions if they don't.

We represented JPM/Chase in this matter, not SunTrust (to my knowledge). The service list is showing another attorney in Orlando as SunTrust's counsel.
