**ORDER GRANTING TRUSTEE'S FOURTH OMNIBUS MOTION
TO APPROVE COMPROMISE OF CONTROVERSIES WITH
SAI FORT MYERS M, LLC, LISA MARIE ENGLER, AND ALEXANDRA KLEINER**

THIS MATTER came before the Court without a hearing on the Fourth Omnibus Motion To Approve Compromise Of Controversies [D.E. 634] (the "Motion") filed by ROBERT E. TARDIF, JR. (the "Trustee"), as Chapter 7 Trustee for the substantively consolidated bankruptcy estates of Ulrich Felix Anton Engler, Private Commercial Office, Inc., and PCO Client Management, Inc. (collectively, the "Debtors"). The Court, having noted that the Motion was served on all creditors and interested parties pursuant to Local Rule 2002-4(a)(5) and that no objections to the Motion were filed, finds that the settlements and compromises referenced in the Motion are reasonable and in the best interests of the Debtors' creditors and the estate. Accordingly, it is,

ORDERED as follows:

1. The Motion is GRANTED.
2. The compromises and settlements between the Trustee and the defendants referenced at paragraphs 10, 12, and 14 of the Motion are hereby approved.

3. The parties are hereby ordered to comply with the terms of the compromises and settlements and are authorized to take all actions deemed necessary and appropriate to consummate the transactions contemplated thereby.

4. The Court reserves jurisdiction to enforce the terms of the compromises and settlements referenced in the Motion and approved by this Order.
