

**ORDER ON MOTION FOR AUTHORITY TO COMPROMISE
CONTROVERSY (DOC. NO. 679)**

THIS CAUSE came before the Court without hearing upon the Trustee's Motion for Authority to Compromise Controversy with Johann Vollnhals, and the Court being fully advised in the premises finds that the motion is well taken, and it is in the best interest of the bankruptcy estate that the Trustee be authorized to compromise the controversy. ORDERED, ADJUDGED and DECREED that the Trustee's Motion is hereby granted, and it is further

ORDERED, ADJUDGED and DECREED that the Trustee is hereby authorized to settle the claim with Johann Vollnhals whereby Johann Vollnhals shall pay to the estate \$13,692.00 (USD) if payment is made by August 30, 2011. After August 30, 2011, settlement shall be in the amount of \$27,384.00 (USD), and in accordance with the terms of the Settlement Agreement previously entered into. It is further.
