

**ORDER ON MOTION FOR AUTHORITY TO SELL PROPERTY OF THE ESTATE FREE AND CLEAR OF LIENS**

THIS CAUSE came before the Court, without a hearing, on the Trustee’s Motion for Authority to Sell Property of the Estate Free and Clear of Liens to Lee County Investment Group, LLC, or their designees or assigns (Doc. 786), and the Court having reviewed the record and being otherwise fully advised in the premises, finds that the Motion is well taken. The Court finds that negative notice was given by the Trustee and no objection and/or response has been filed. It is, therefore

ORDERED, ADJUDGED AND DECREED that the Motion is hereby granted. It is further

ORDERED, ADJUDGED AND DECREED that the Trustee is hereby authorized to sell the following described property to Lee County Investment Group, LLC, or their designees or assigns, for the sum of \$4,000.00, free and clear of liens: Lots 9 & 10, Block 3626, Unit 49, Cape Coral – 1140 S.W. 3<sup>rd</sup> Street, Cape Coral, Florida. It is further

ORDERED, ADJUDGED and DECREED that the Trustee is hereby authorized to pay the following from the proceeds of sale:

- 1. Jessie Leopard, P.A./ReMax Realty Team/Cooperating Broker, if any) \$ 600.00
- 2. Other customary closing costs to the Trustee, as Seller, including:
  - a. Title Insurance \$ 0.00
  - b. Closing & Related Fee \$ 150.00
  - c. Documentary Stamps \$ 28.00
  - d. Condo Assessments of approximately \$ 0.00
  - e. Reasonable and customary closing costs not to exceed \$ 100.00
  - f. Prorated taxes, back taxes, assessments of approximately \$ 275.00

and it is further

ORDERED, ADJUDGED and DECREED that the purported liens or interests of any purported claimants and/or lienors shall be transferred to and shall have the same priority, if any, to the proceeds of the sale.
