**TRUSTEE'S MOTION FOR AUTHORITY TO COMPROMISE CONTROVERSY**

Notice is given that the Trustee will compromise all claims that the estate may have against ROBERT DOERR.

**NOTICE OF OPPORTUNITY TO OBJECT AND FOR HEARING**

Pursuant to Local Rule 2002-4, the Court will consider this motion, objection or other matter without further notice or hearing unless a party in interest files an objection within 21 days from the date this paper is entered on the docket. If you object to the relief requested in this paper, you must file your objection with the Clerk of the Court at Sam M. Gibbons United States Courthouse, 801 N. Florida Avenue, Suite 555, Tampa, Florida 33602, and serve a copy on the Trustee, Robert E. Tardif Jr., Post Office Box 2140, Fort Myers, Florida 33902 and on the Assistant United States Trustee, 501 E. Polk Street, Suite 1200, Tampa, Florida 33602.

If you file and serve an objection within the time permitted, the Court may schedule a hearing and you will be notified. If you do not file an objection within the time permitted, the Court will consider that you do not oppose the granting of the relief requested in the paper, will proceed to consider the paper without further notice or hearing, and may grant the relief requested.

**NATURE OF CONTROVERSY & TERMS OF COMPROMISE**

The Debtor operated a Ponzi scheme. After investigation, the Trustee believed that he had certain claims to financial accounts. The Trustee filed an adversary proceeding to determine the Trustee's rights to financial accounts with funds originating from the Debtors and for turnover of the funds in the account. After full disclosure the Trustee and Doerr agree to resolve any and all claims of the estate against Doerr, by Doerr agreeing to payment of \$10,336.36 and he will not object to turnover by the United States Secret Service of the sum of \$827,654.48, a 2007 Cadillac Escalade VIN 1GYFK63807R355159 and a 2007 Cadillac Convertible VIN 1G6YV36A075601172 that Doerr previously turned over to the Secret Service.

**REASON FOR COMPROMISE**

The compromise is in the best interest of the estate and will save the estate from an unnecessary, and possibly unproductive, expenditure of legal fees and costs and is in the best interest of the creditors of the estate. The compromise has also been recommended by special counsel for the Trustee.
