**SUNTRUST BANK'S NOTICE OF WITHDRAWAL OF MOTION FOR
ENLARGEMENT OF TIME TO FILE AND SERVE
A RESPONSE BRIEF (DKT. 968)**

SunTrust Bank ("SunTrust"), by and through its undersigned counsel, hereby notifies the Court and all interested parties that it hereby withdraws its Motion for Enlargement of Time to File and Serve a Response Brief which was inadvertently filed in the bankruptcy proceeding, and states as follows:

1. On August 1, 2013, SunTrust filed a Motion for Enlargement of Time to File and Serve a Response Brief (the "Motion" (Dkt. 968).
2. Due to inadvertent error, this Motion was filed in the main bankruptcy case and not in the related appeal pending before this Middle District as case 2:13-cv-00480-JES.
