**STIPULATION AND CONSENT ORDER REGARDING EXTENSION OF DEADLINE
FOR FILING CHALLENGES TO PREPETITION OBLIGATIONS**

The Pre-Petition Agent (as defined in the Final Order (defined below)), on behalf of the Pre-Petition Lenders (as defined in the Final Order), and the Official Committee of Unsecured Creditors (the “Committee”) of Exide Technologies and its related debtors and debtors-in-possession in the above captioned cases (collectively, the “Debtors”), by and through their respective undersigned counsel, hereby stipulate and agree that the date established in paragraph 17 of the Final Order Authorizing Debtors in Possession to Enter into Post-Petition Credit Agreement and Obtain Post-Petition Financing Pursuant to Sections 363 and 364 of the Bankruptcy Code, Providing Adequate Assurance, and Granting Liens, Security Interests and Super-Priority Claims, which order was approved by the Court on May 10, 2002 and entered as docket number 218 (the “Final Order”), is extended until November 18, 2002 at 4:00 p.m. Eastern Time, provided, however, that such date may only be extended further with the consent of the Pre-Petition Agent. Such date refers to the date up until which the Committee shall have the right to assert Claims and Defenses (as defined in the Final Order) in an action commenced in the United States Bankruptcy Court for the District of Delaware and related matters.

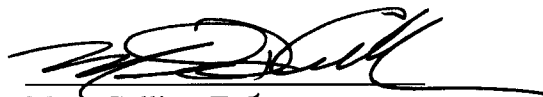

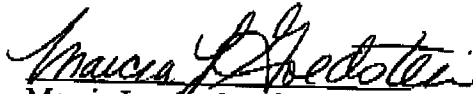
