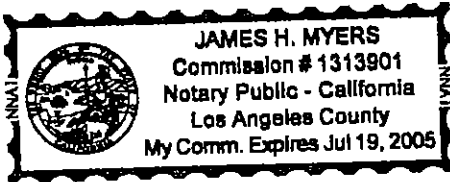



**NOTICE REJECTING CERTAIN EXECUTORY
CONTRACTS AND UNEXPIRED LEASES**

1. The above captioned debtors and debtors in possession (collectively, the "Debtors") submit this notice to reject (the "Notice"), pursuant to section 365 of the Bankruptcy Code, the executory contracts and/or unexpired leases (individually, a "Contract" and, collectively, the "Contracts") referred to on Exhibit A attached hereto.

2. This Notice is made pursuant to the Order Pursuant to Sections 365 and 554 of the Bankruptcy Code Authorizing and Approving an Expedited Procedure for the Rejection of Executory Contracts and Unexpired Leases of Non-Residential Real Property and Abandonment of Property of the Debtors (the "Lease Rejection Procedures Order") (Docket No. 62).

3. Should a party-in-interest object to the proposed rejection described herein, such party must file and serve a written objection so that such objection is filed with the Bankruptcy Court for the District of Delaware, 824 Market Street, Wilmington, Delaware 19801, and is actually received by the following parties **no later than thirty (30) days after the date of service of this Notice**: (a) counsel to the Debtors, Kirkland & Ellis, 200 East Randolph Drive, Chicago, Illinois 60601, Attn: Matthew N. Box 8705, Wilmington, Delaware 19899-8705, Attn: Laura Davis Jones, Esq.; (b) counsel to the Committee of Unsecured Creditors Akin, Gump, Strauss, Hauer & Feld, L.L.P., 590 Madison Avenue, New York, NY 10022, Attn: Fred Hodara, Esq.; (c) counsel to the Administrative Agent to the Prepetition Lenders, Sherman & Sterling, 599 Lexington Avenue, New York, New York 10022, Attn: Douglas Bartner, Esq.; (d) counsel to the Post-Petition Lenders, Weil, Gotshal & Manges, 767 Fifth Avenue, New York, New York 10153, Attn: Marcia L. Goldstein, and (e) Office of the United States Trustee, 844 King Street, Room 2313, Lockbox 35, Wilmington, Delaware 19801, Attn: Mark Kenney, Esq.

4. Absent an objection being filed and served, as described above, within thirty (30) days after the date the Debtors file this Notice, the rejection of the Contract(s) shall become effective retroactively as of the date the Notice was filed with the Court (the "Effective Date") without further notice, hearing or order of the Court.²

² An objection to the rejection of any particular Contract listed in the Notice shall not constitute an objection to the rejection of any other Contract listed in the Notice. Any objection to the rejection of any particular Contract listed in the Notice must state with specificity the Contract to which it is directed. For each particular Contract whose rejection is not timely or properly objected to, such rejection will be effective in accordance with this Notice and the Lease Rejection Procedures Order.

5. If an objection is properly filed and served, the Court will schedule a hearing to consider the objection only with respect to the rejection of a Contract(s) as to which an objection was properly filed and served. If such objection is withdrawn, the rejection of the Contract shall be deemed to have occurred on the Effective Date. If such objection is ruled upon by the Court, the Court shall determine the effective date of rejection.

6. Pursuant to the Lease Rejection Procedures Order, if a party wishes to file a claim, if any, arising from, or as a consequence of, the rejection of a Contract(s), such party must file a proof of claim for such claim on or before thirty (30) days after the Effective Date (the "Deadline").

7. Proofs of claim should conform substantially to Form No. 10 of the
