MOTION OF ENERSYS, INC. FOR AN ORDER EXPEDITING TIME FOR THE HEARING TO CONSIDER ITS EMERGENCY MOTION FOR THE ENTRY OF AN ORDER AUTHORIZING AN EXAMINATION OF EXIDE TECHNOLOGIES, INC. PURSUANT TO BANKRUPTCY RULE 2004

For the reasons stated in the Motion, EnerSys needs an order allowing it to conduct an examination of Exide Technologies, Inc. under Federal Rule of Bankruptcy Procedure 2004 as soon as possible. Upon information and belief, the Official Committee of Unsecured Creditors supports this motion.

WHEREFORE, EnerSys respectfully requests that the Court enter an order expediting the time for hearing on the Motion and allow argument on the Motion at the earliest convenience of the Court.
