US Foods Claim entitled to the PACA trust is **\$2,374.11**. This amount is further asserted as a secured claim. A summary of the goods and invoices related to the PACA claim is attached hereto as **Exhibit B**.

3. Certain of the goods provided by US Foods in the ordinary course of the Debtor's business were received by the Debtor within 20 days before the Petition Date. Section 503(b)(9) provides administrative priority for "the value of any goods received by the debtor within 20 days before the date of commencement of a case under this title in which the goods have been sold to the debtor in the ordinary course of such debtor's business." 11 U.S.C. § 503(b)(9); *see also* 11 U.S.C. § 507(a)(2) (providing priority to "administrative expenses allowed under section 503(b)" of the Bankruptcy Code). Accordingly **\$43,461.95** of the US Foods Claim is entitled to administrative priority, as indicated on Exhibit A.

4. US Foods reserves its right to update and/or supplement the US Foods Claim at any time and to assert any and all other claims of whatever kind or nature that it has, or it may have, against the Debtor. The filing of the US Foods Claim shall not be deemed a waiver or release of any of US Foods' claims or rights, an election of remedy, or a waiver of any past, present or future defaults or events of default under all applicable agreements or other operative documents. Further, nothing contained herein shall be deemed or construed as a waiver of any additional administrative expense claims that US Foods has or may have against the Debtor, and US Foods retains the right to assert such claims.
