- I am a former employee of Fox Ortega Enterprises, Inc., dba Premier Cru ("Debtor") and have been retained to assist Michael G. Kasolas ("Trustee") by looking up information, preparing reports derived from the Debtor's books and records, and providing information related to the Debtor's pre-bankruptcy operations as requested by the Trustee, his counsel, or the Class Action. The following facts are true of my own personal knowledge and if called upon to do so, I would and could competently testify thereto, except as to those matters that are alleged upon information and belief and as to those matters, I believe them to be true.
- 2 I have reviewed the list of bottles that Malik M. Hasan ("Dr. Hasan") attached as Exhibit A to his objection ("Third Party Bottles").
- 3. The Third Party Bottles references 6 bottles of Cheval Blanc 2010; however, there are no such bottles in the warehouse. I assume Dr. Hasan is referring to the 2009 vintage of the Cheval Blanc, some of which are allocated to Dr. Hasan, and which the Trustee already pulled from the sale.
- 4. Attached hereto as **Exhibit A** is a list of bottles that are allocated to Dr. Hasan and which I am informed and believe are not part of the sale since Dr. Hasan opted out of the Class Action.
- 5. The Third Party Bottles listed in Dr. Hasan's Objection have been allocated to other customers. Additionally, all of those customers placed their order before Dr. Hasan placed his orders, with one exception. One customer who was allocated a bottle purchased his bottle after Dr. Hasan. However, that customer was allocated a higher priority in connection with a lawsuit. If that customer had not been allocated that wine, there were other customers who purchased that wine before Dr. Hasan who in the normal course of business would have been allocated the bottle before Dr. Hasan.
- 6. The Premier Cru allocation was not arbitrary. While the Premier Cru records did not allocate a specific bottle to a specific purchaser, the Premier Cru MAS system indicates that a specific vintage and variety is allocated to a customer based on a first purchased, first allocated concept. All customers had sale orders, only some had wines allocated.

- 7. On certain occasions John Fox overrode the allocation to send bottles to someone outside of the allocation priority at their request.
- 8. To the best of my knowledge after reviewing the Debtor's records, the address listed for Dr. Hasan in the Bankruptcy pleadings is the address that Premier Cru has used for him, and it appears to have been the address used on at least one occasion to ship wine to Dr. Hasan.

I declare under penalty of perjury that the foregoing is true and correct, and that this declaration was executed on August 23, 2016, at Berkeley, California.
