NOTICE OF CONTINUED HEARING AND DEADLINE FOR FILING OPPOSITION

On November 16, 2016, the Chapter 7 Trustee filed the *Notice of Hearing on Application for Compensation and Reimbursement of Expenses by Professionals for Trustee* (doc. 467) (the "Notice"), thereby setting a hearing date for December 7, 2016 on various applications for compensation and reimbursement of expenses (docs. 455, 464, 465, and 466) (collectively, the "Fee Apps"). Having reviewed the Fee Apps, and given the complexities of this case and the significant nature of the amounts being requested, the Court held a status conference on November 28, 2016. Appearances were noted on the record. The purpose of the status conference was to allow the parties and the Court an opportunity to preliminarily discuss any issues, such as the logistics of how such fees would be paid by the estate, which could be reasonably anticipated.

In order to allow all parties in interest a meaningful opportunity to review the Fee Apps and to file an opposition, if any, the Court determined that it would be best to continue the

1 scheduled hearing on the Fee Apps. Therefore, the Court HEREBY GIVES NOTICE of the
2 continued hearing and accompanying deadlines as follows:

- 6 2. Any opposition to the Fee Apps must be filed on or before **December 7, 2016**.
- 7 3. Arent Fox, LLP, who filed the fee application entered at docket entry number 464,
8 must file the supplemental information requested by the Court at the status
9 conference on November 28, 2016 on or before **December 7, 2016**.
