3 A hearing on the *First Interim Fee Application of Arent Fox LLP for Allowance*
4 *and Payment of Compensation and Reimbursement of Expenses for the Period from*

15 **IT IS HEREBY ORDERED THAT:**

16 1. The Application is APPROVED on an interim basis in the reduced amounts
17 agreed to by and between Arent Fox LLP and the United States Trustee;

18 2. Arent Fox LLP is allowed on an interim basis a total of \$13,595.74
19 representing \$13,144.00 in allowed fees and \$451.74 in allowed reimbursable expenses.

20 3. Michael G. Kasolas in his capacity as chapter 7 trustee of the above-
21 captioned bankruptcy estate is authorized and directed to immediately pay Arent Fox LLP
22 \$9,652.54, representing 70% of the fees allowed on an interim basis and 100% of the
23 expenses allowed on an interim basis.
