**REQUEST FOR ENTRY OF ORDER BY
DEFAULT AUTHORIZING AND
APPROVING PAYMENT OF
ADMINISTRATIVE EXPENSE CLAIM
OF WEST AUCTIONS, INC.**

19 TO: THE HONORABLE WILLIAM J. LAFFERTY, III, UNITED STATES BANKRUPTCY
20 JUDGE, OAKLAND, CALIFORNIA:

21 Michael G. Kasolas, trustee herein ("Trustee"), requests that the Court enter an order
22 granting his *Motion for Order Authorizing Payment of Administrative Expense Claim of West*
23 *Auctions, Inc.* ("Motion"), filed on November 22, 2016 (Docket No. 472) as described in the
24 Trustee's *Notice of Opportunity for Hearing on Motion for Order Authorizing Payment of*
25 *Administrative Expense Claim of West Auctions, Inc.* ("Notice"), filed on November 22, 2016, and
26 entered as Docket No. 473, a true and correct copy of which Notice, together with Certificate of
27 Service are attached as Exhibits A and B, respectively, to the Declaration of Elizabeth Berke-
28 Dreyfuss filed in support hereof ("Declaration").

1 The Notice was duly served on November 22, 2016 on those parties requesting special
2 notice and on those parties who have requested email service by BMC Group, Inc. in accordance
3 with the *Order Establishing Certain Noticing Procedures* entered on February 23, 2016 [Docket
4 No. 94]. The Notice provided, pursuant to Bankruptcy Rules 9019 and 6004 and Bankruptcy
5 Local Rule 9014-1(b)(3), that unless an objection or request for hearing was filed in response to
6 the Notice within 21-days from the date of the mailing of the Notice, an order approving the relief
7 requested may be entered without further notice or opportunity to be heard. The last day to have
8 timely filed and served an objection or request for hearing pursuant to the Notice was December
9 13, 2016.

10 No timely objections or requests for hearing were filed or served in response to the Notice.

11 For the reasons stated in the Notice, the Trustee requests approval of and authority to pay
12 West Auctions, Inc. its administrative expense claim in the total amount of \$21,512.00.

13 WHEREFORE, the Trustee requests that the Court enter an order granting his Motion.
