- 1. Michael G. Kasolas ("Trustee"), the duly appointed and acting Chapter 7 Trustee in the bankruptcy estate of Fox Ortega Enterprises, Inc. (the "Debtor"), hereby reports the completion of the sale of the Debtor's personal property, commonly known as "Inventory On Site" as per the Debtor's original petition, as Asset #4 [Doc#1].
- 2. The Court approved the sale by Order Authorizing and Approving Sale of Wine Free and Clear of Liens, entered on September 2, 2016 [Doc#397].
- 3. Pursuant to the Second Amended Sale Agreement and Second Amended Unfettered Sale Agreement, which are collectively referred to as the "Agreements" and the Order Authorizing and Approving Sale of Wine Free and Clear of Liens entered on September 2, 2016 [Doc#397] (the Order [Doc#397]), Spectrum Wine Auctions (Spectrum) purchased the Debtor's interest in the personal property referred to in the Agreements as "Primary Wine Bottles" and "Unfettered Wine Bottles" (the wine), for \$3,550,000.00 and \$126,000, respectively. The price of the wine was subject to adjustments for "opt-out" bottles, "bad bottles" and "missing bottles", as provided in the Order [Doc#397] which netted to \$236,188.77. Further, pursuant to the Order [Doc#397], eight Class Members effectively and timely redeemed certain bottles of wine for the sum of \$9,584.77.

1	The final net payment for the wine, adjusted for rejected "bad bottles", "missing bottles" and "opt-
2	out" bottles, as defined in the Agreements, was received from Spectrum on January 23, 2017.
3	Thus, the net proceeds to the estate totaled, \$3,449,396.00.
