If there is no timely objection to the requested relief or a request for hearing, the court  
may enter an order granting the relief by default;

1 The initiating party will give at least seven (7) days written notice of the hearing to the  
2 objecting or requesting party, and to any trustee or committee appointed in the case.

3 Any objection or request for hearing should be served on the undersigned and filed with  
4 the Clerk of the United States Bankruptcy Court, Northern District of California, Oakland  
5 Division, 1300 Clay St Rm 300, Oakland California 94612.
