UNDER OMNIBUS PROCEDURES FOR
NOTICE AND SETTLEMENT**

19 Upon consideration of the trustee's *Motion for Authority, Pursuant to Bankruptcy Rules*
20 *9019(b) and 2002(a), to Settle and Compromise Avoidance Actions Under Omnibus Procedures*
21 *for Notice and Settlement* filed herein on March 10, 2017 [Doc. # 515] (the "Motion"), and the
22 trustee's *Request for Relief* filed pursuant to Bankruptcy Local Rule 9014-1(b)(4), and it appearing
23 from the Declaration of Mark Bostick filed in support thereof that the trustee's *Notice of*
24 *Opportunity for Hearing on Motion* [Doc. #516] (the "Notice") was duly served on all parties
25 entitled to notice on March 31, 2017, and no party filed or served an objection or request for
26 hearing in response thereto; and for good cause,

27 IT IS ORDERED:

- 28 1. The Motion is granted;

- 1 2. The settlement procedures set forth in Paragraphs 6-8 of the Motion are approved.
- 2 3. The settlement parameters set forth under Paragraph 6(i)-(iii) of the Motion are fair
- 3 and equitable and are approved.
- 4 4. The trustee is authorized to settle avoidance claims within the settlement
- 5 parameters set forth under Paragraph 6(i)-(iii) of the Motion without further notice or hearing and
- 6 any such settlement shall be deemed approved and enforceable without further order of this Court,
- 7 except that as to the settlement of any claim for \$250,000.00 or more, notice under Bankruptcy
- 8 Rule 9019(a) and further court approval shall be required, regardless of the percentage that is to be
- 9 recovered.
- 10 5. This Court shall retain jurisdiction to hear and determine all matters arising from or
- 11 related to implementation, interpretation or enforcement of this Order.
