

**NOTICE AND OPPORTUNITY FOR
HEARING ON MOTION FOR ORDER
APPROVING COMPROMISE WITH EAST
WEST BANK**

TO: THE TWENTY LARGEST CREDITORS, PARTIES REQUESTING SPECIAL NOTICE, THE U.S. TRUSTEE, THE DEBTOR AND OTHER INTERESTED PARTIES:

PLEASE TAKE NOTICE THAT Michael G. Kasolas ("Kasolas" or "Trustee"), the chapter 7 trustee for the bankruptcy estate of above-captioned debtor ("Debtor"), has filed a motion under Bankruptcy Rule 9019 (the "Motion") for an order approving his compromise with East West Bank. The Motion is based on the facts and merits summarized below.

The Compromise Terms

Under the proposed compromise, the trustee will release East West Bank from all claims in exchange for its payment of \$397,733.44 plus its waiver of all claims against the Debtor's estate.

Factual Background and Merits of Compromise

On January 8, 2016, the Debtor filed its voluntary petition for relief under Chapter 7 of the United States Bankruptcy Code (the Filing Date"). Kasolas is the duly appointed trustee in the case.

From December 2010 through December 2015, the Debtor paid East West Bank monthly payments totaling \$479,196.91 (the "Transfers") on account of a mortgage note owed by John Fox, the Debtor's chief executive officer, secured by his residence. The Trustee contends that he may avoid the Transfers are avoidable under 11 U.S.C. §548(a) and Cal Civil Code §3439 et seq. East West Bank disputes the Trustee's contentions.

The Trustee submits that the proposed compromise is fair and equitable and in the best interests of creditors and the estate under the factors set forth in *In re A&C Properties*, 784 F.2d 1377 (9th Cir. 1986), *cert denied*, 479 U.S. 854 (1986), because: (1) it enables the estate to recover 90% of the Transfers made within 4 years of the Filing Date plus about 50% of the Transfers made within 5-7 years before the Filing Date, for a total blended average of 83% recovery on all Transfers made within 7 years of the Filing Date - without requiring further litigation expense, risk or delay; (2) the 17% difference between the claim and the settlement amount could well be less than the cost to litigate the claim; (3) the settlement eliminates any delay or risk of non-recovery.

Procedure to Object and Request a Hearing

PLEASE TAKE FURTHER NOTICE that this matter is governed by Bankruptcy Local Rule 9014-1(b)(3), which states:

Any objection to the requested relief, or a request for hearing on the matter, must be filed and served upon the initiating (undersigned) party within twenty-one (21) days of mailing the notice (i.e. by May 15, 2017.

Any objection or a request for a hearing must be accompanied by any declarations or memoranda of law any requesting party wishes to present in support of its position;

If there is no timely objection to the requested relief or a request for hearing, the court may enter an order granting the relief by default;

The initiating party will give at least seven (7) days written notice of the hearing to the objecting or requesting party, and to any trustee or committee appointed in the case.

Any objection or request for hearing must be served on the undersigned and filed with the Clerk of the United States Bankruptcy Court, Northern District of California, Oakland Division, 1300 Clay Street, Room 300, Oakland, CA 94612, or in the case via Pacer.

PLEASE TAKE FURTHER NOTICE that the Motion and supporting declaration of Mark S. Bostick together with a copy of the parties' settlement agreement are filed and may be obtained from the Bankruptcy Court Clerk, through Pacer at <https://ecf.canb.uscourts.gov/>, or upon request from the undersigned.
