Bankruptcy Procedure, and the Guidelines for Compensation and Expense Reimbursement for Professionals and Trustees of the United States Bankruptcy Court for the Northern District of California (the "Guidelines").

## **Background**

- 1. This is BMC's second application for interim compensation for services rendered and reimbursement of expenses incurred while providing assistance to the Trustee with: (i) establishing a website for creditors to review pleadings and other information the Trustee may choose to post, (ii) serving creditors who opt for electronic notice of pleadings filed, (iii) maintaining the Debtor's mailing matrix of over 9,250 parties, (iv) serving copies of notices when required to be mailed to all creditors, (v) assisting with managing the proofs of claims, and (vi) preparing and mailing checks and related tax documents.
- 2. BMC's employment was granted pursuant to the "Order Approving Employment of BMC Group, Inc." ("BMC Employment Order") entered on the Court's docket at Docket Number 95, on or about February 23, 2016. As set forth in the BMC Employment Order and related pleadings, BMC did not receive any retainer from the Trustee or the estate in contemplation of its services and expenses.
- 3. Pursuant to the "Order Approving First Interim Application for Compensation and Reimbursement of Expenses by BMC Group, Inc." entered on or about December 16, 2106 at Docket No. 499, the Court granted BMC's first interim application, allowed \$21,079.00 in fees requested, subject to a 30% holdback pending further Court order, and allowed 100% of BMC's \$32,926.44 of costs incurred, and authorized the Trustee to pay 70% of the fees, and 100% of the costs upon entry of the Order. Thereafter, pursuant to the "Order Authorizing Payment of Administrative Fees and Expenses Incurred to Administer Class Settlement and Authorizing Payment of Previously Allowed Professional Fees" entered on or about July 14, 2017 at Docket No. 568, the Court authorized the payment of BMC's fees and expenses in the amount of \$22,064.13 incurred to administer the class settlement and payment of the 30% holdback amount from BMC's First Interim Fee Application in the amount of \$6,323.70. Other than as set forth herein, BMC has received no other payments on account of its services rendered or expenses

incurred.

## **Case Status**

4. BMC incorporates herein by reference the case status and narrative history provided in the Application for Compensation of Wendel, Rosen, Black & Dean LLP, attorneys for the Trustee, filed contemporaneously herewith.

## **Summary of Services Rendered**

- 5. By this Application, BMC seeks interim allowance of its reasonable and necessary fees for services rendered, in the amount of \$29,018.00, together with reimbursement of its actual and necessary expenses incurred, in the amount of \$24,014.35 during the Application Period. Pursuant to the requests of the Trustee, BMC has broken out the fees and expenses allocable to Fox Ortega Enterprises ("FOE") and those allocable to Class Action ("Class Action"). Of the total amounts requested herein, \$19,250.50 in fees and \$18,805.93 in expenses are allocable to FOE and \$9,767.50 in fees and \$5,208.42 in expenses allocable to Class Action.
- 6. Attached to the "Declaration of Varouj Bakhshian in Support of Second Application of BMC Group, Inc. for Interim Compensation for Services Rendered and Reimbursement of Expenses Incurred" ("Bakhshian Declaration") as Exhibit A is a detailed statement of fees for services rendered by BMC during the Application Period, which includes: : (i) a description of the individual timekeeper performing the services; (ii) the date the services were performed; (iii) whether the services were for Fox Ortega Enterprises or related to the Class Action; (iv) a detailed description of the nature of the services and the related time expended; (v) a summary of the hours and total compensation requested by timekeeper, and each timekeeper's biographical information; and (vi) a summary of the hours and total compensation for each project category. During the Application Period, BMC allocated its services into seven basic categories. The discussion below provides an overview of the services performed by BMC by category as set forth in the Bakhshian Declaration filed concurrently herewith:

## Valuation of Services

- 8. In accordance with the factors enumerated in Section 330 of the Bankruptcy Code, the amounts requested herein for compensation and expense reimbursement are fair and reasonable given (a) the complexity of this case, (b) the time expended by the individual timekeepers at BMC, (c) the nature and extent of the services rendered, (d) the value of such services, and (e) the costs of comparable services other than in a case under this title.
- 9. As set forth in the Bakhshian Declaration, BMC certifies that (i) it has reviewed the requirements of the Guidelines and (ii) that this Application complies with the Guidelines.

WHEREFORE, the Trustee requests that this Court (a) allow compensation for professional fees and services provided during the Application Period, October 1, 2016 through October 31, 2017, on an interim basis in the amount of \$29,018.00, and reimbursement of actual and necessary expenses during the Application Period in the amount of \$24,014.35; (b) authorize and direct the Trustee to remit payment to BMC for professional fees and services provided during the Application Period in the amount of \$29,018.00 and reimbursement of actual and necessary expenses incurred during the Application Period in the amount of \$24,014.35; and (c) grant such other and further relief as the Court deems just and proper.
