**STIPULATED ORDER ON  
CLAIM FILED BY CB LEASING INC.**

This Stipulated Order on the claim filed by CB Leasing Inc. (“CB Leasing”) is proposed by the Debtors and CB Leasing.

**RECITALS**

1. On May 31, 2002, the Debtors filed with this Court a voluntary petition for relief under Chapter 11 of the Bankruptcy Code. The Debtors continue to operate their businesses and manage their properties as debtors in possession in accordance with Sections 1107 and 1108 of the Bankruptcy Code.
2. On December 2, 2002, CB Leasing filed proof of claim number 4769 asserting an unsecured priority claim against Farmland Foods, Inc. in the amount of \$9,636.00.
3. Debtors dispute that CB Leasing’s claim is entitled to priority and dispute the amount of the claim.
4. Debtors and CB Leasing have agreed to resolve the dispute under the terms set forth below.

**STIPULATED ORDER**

5. CB Leasing shall be allowed a general unsecured claim against Farmland Foods, Inc. in the amount of \$7,836.00.

6. Each person proposing this Stipulated Order represents that he or she has full authority and capacity to make the commitment contained in this Stipulated Order.
