**STIPULATED ORDER ON DEBTORS' OBJECTION
TO CLAIM FILED BY LES & DEAN PAUSTAIN, d/b/a AGP**

This Stipulated Order on the Debtors' objection to the claim filed by Les & Dean Paustain, d/b/a AGP ("Paustain") is proposed by the Debtors and Paustain.

RECITALS

1. On May 31, 2002, the Debtors filed with this Court a voluntary petition for relief under Chapter 11 of the Bankruptcy Code. The Debtors continue to operate their businesses and manage their properties as debtors in possession in accordance with Sections 1107 and 1108 of the Bankruptcy Code.
2. On January 9, 2003, Paustain filed proof of claim number 8127 asserting an unsecured priority claim against Farmland Industries, Inc. in the amount of \$10,400.00.
3. On September 5, 2003, the Debtors objected to Paustain's claim in their Sixth Omnibus Objection to Misclassified Claims and Request to Reclassify as General Unsecured Claims (docket #5286). On September 22, 2003, Paustain filed a response to the objection (docket #5779).
4. The Debtors and Paustain have agreed to resolve the objection under the terms set forth below.

STIPULATED ORDER

5. Paustain shall be allowed a general unsecured claim in the amount of \$10,400.00 against Farmland Industries, Inc.

6. Each person proposing this Stipulated Order represents that he or she has full authority and capacity to make the commitment contained in this Stipulated Order.
