**STIPULATED ORDER ON DEBTORS' OBJECTION  
TO CLAIM OF KANOMA CO-OP ASSOCIATION**

This Stipulated Order on the Debtors' objection to the claim of Kanoma Co-op Association ("Kanoma") is proposed by the Debtors and Kanoma.

**RECITALS**

1. On May 31, 2002, the Debtors filed with this Court a voluntary petition for relief under Chapter 11 of the Bankruptcy Code. The Debtors continue to operate their businesses and manage their properties as debtors in possession in accordance with Sections 1107 and 1108 of the Bankruptcy Code.

2. Farmland Industries, Inc. ("FII") scheduled a prepetition debt owed to Kanoma in the amount of \$51,285.84. Kanoma owes FII the sum of \$639.17 for prepetition services, which Kanoma would be entitled to offset against the prepetition sum owed by FII. The net amount owed by FII to Kanoma for prepetition debt is \$50,646.67.

3. Kanoma owes FII the amount of \$837.96 for post-petition services.

4. On September 5, 2003, the Debtors objected to Kanoma's claim in their First Omnibus Objection to Claims Under Sections 502(d) and 542(b) of the Bankruptcy Code (docket #5279). On September 15, 2003, Kanoma filed its response to the objection (docket #5495).

5. The Debtors and Kanoma have agreed to resolve the objection under the terms set forth below.

**STIPULATED ORDER**

6. Kanoma shall be allowed a general unsecured claim in the amount of \$50,646.67 against Farmland Industries, Inc.

7. Kanoma shall remit the sum of \$837.96 to the Debtors for post-petition services within 10 days of the date the Court enters this Stipulated Order.

8. Each person proposing this Stipulated Order represents that he or she has full authority and capacity to make the commitment contained in this Stipulated Order.
