**NOTICE OF CONTINUED PERFECTION
PURSUANT TO CODE SECTION 546(b)(2) OF
MECHANIC'S LIEN OF GRIFFITH STEEL ERECTION, INC.**

COMES NOW Griffith Steel Erection, Inc. ("Griffith"), by and through its counsel, William A. Wells of Young, Bogle, McCausland, Wells & Blanchard, P.A., and submits its Notice of Continued Perfection Pursuant to Code Section 546(b)(2). In support of its Notice, Griffith alleges and states as follows:

- 1. Griffith is a Kansas Corporation with a principal place of business at Griffith Steel Erection, Inc., 5059 N. Ridge Rd., Wichita, KS 67205.**
- 2. On or about March 7, 2002, at the request of the Debtor, Griffith last provided labor, materials and supplies for construction of certain improvements to a meat processing plant owned by Debtor and located on Debtor's real estate in Wichita, Kansas, described as follows:**

Lot One (1), Safeway Second Addition, City of Wichita, Sedgwick County, Kansas, commonly known as 2323 S. Sheridan, Wichita, KS.
- 3. On June 3, 2002, Griffith filed a Mechanic's Lien Statement for labor, services and materials it provided to Debtor with the Clerk of the Sedgwick County District Court, where the labor, services and materials were provided by Griffith and where Debtor's property is located. A true and correct copy of said Mechanic's Lien Statement and detailed listing of charges is attached collectively as Exhibit "A".**

4. Under the laws of the State of Kansas, Griffith has a valid perfected Mechanic's Lien in the described real estate.

5. Under the laws of the State of Kansas, Griffith must commence an action to foreclose its mechanic's lien in the real estate within one year of the filing of its lien statement or its lien will cease to exist.

6. The automatic stay in this case prevents Griffith from commencing an action to foreclose its mechanic's lien in the real estate.

7. As a result, Griffith submits this Notice of Continued Perfection Pursuant to Code Section 546(b)(2) and hereby declares that this mechanic's lien in the real estate continues to exist and continues to be perfected.
