NOTICE OF CONTINUED PERFECTION
PURSUANT TO CODE SECTION 546(b)(2)**

COMES NOW Secured Creditor Alliance Process Partners, L.L.C., d/b/a International Alliance Group (“IAG”), and submits its notice of continued perfection pursuant to Code Section 546(b)(2). In support of its notice, IAG alleges and states as follows:

1. IAG is a Delaware Limited Partnership with its principal place of business in Houston, Texas, and is duly authorized to do business in the State of Kansas.
2. At the request and consent of the Debtor, IAG last furnished labor and materials for work performed at Farmland Industries Refinery, North and Linden Streets, Coffeyville, Montgomery County, Kansas, on April 4, 2002. Said work was performed pursuant to a contract with the debtor.
3. On June 5, 2002, IAG filed two artisan’s lien statements against personal property in Montgomery County, Kansas, for the work it performed at Farmland Industries Refinery. True and correct copies of the artisan’s lien statements were filed with the Court as Exhibits A and B with IAG's Motion for Relief From or Modification of Automatic Stay (filed September 13, 2002, Docket No. 759) and are incorporated herein by express reference.
4. On September 3, 2002, IAG filed its proof of claim in this matter.

5. Under the laws of the State of Kansas, IAG has validly perfected artisan's liens on the personal property located at the Farmland Industries Refinery as described in Exhibit A and Exhibit B of IAG's Motion for Relief From or Modification of Automatic Stay referenced in paragraph 3 of this Notice.

6. Under the laws of the State of Kansas, IAG must commence an action to foreclose its artisan's liens on said personal property on or before June 5, 2003, or its lien will cease to exist.

7. The automatic stay in this case prevents IAG from commencing an action to foreclose its artisan's liens on Farmland Foods, Inc.

8. As a result, IAG submits this notice of continued perfection pursuant to Code Section 546(b)(2) and hereby declares that its artisan's liens on the Farmland Industries Refinery continue to exist and continue to be perfected, and will continue to exist and be perfected after June 5, 2003.
