**NOTICE OF NON-EXHAUSTIVE LIST OF POTENTIAL
CAUSES OF ACTION PURSUANT TO DEBTORS'
SECOND AMENDED JOINT CHAPTER 11 PLAN**

PLEASE TAKE NOTICE that, on December 4, 2013, the above captioned debtors and debtors in possession (the "Debtors")¹ filed their *Second Amended Joint Chapter 11 Plan* [Docket No. 1007] (as it may be amended, modified, or supplemented from time to time, the "Plan").² A hearing with respect to confirmation of the Plan is scheduled to be held before the Honorable D. Michael Lynn, United States Bankruptcy Judge, in the U.S. Bankruptcy Court for the Northern District of Texas, 501 W. 10th Street, Fort Worth, Texas 76102, on January 15, 2014 at 1:30 p.m. (prevailing U.S. Central Time).

¹ The Debtors in these Chapter 11 cases are: (i) FiberTower Network Services Corp.; (ii) FiberTower Corporation; (iii) FiberTower Licensing Corp.; and (iv) FiberTower Spectrum Holdings, LLC.

² All capitalized terms used herein that are not otherwise defined in this notice have the meaning set forth in the Plan.

The Plan provides for the preservation of all Causes of Action owned by the Debtors. Pursuant to Section 6.5 of the Plan, a Litigation Trust shall be formed, and all Litigation Trust Assets belonging to the Debtors and their chapter 11 estates shall be vested in the Litigation Trust. The Litigation Trust Assets consist of (i) any claims or Causes of Action arising under chapter 5 of the Bankruptcy Code (or the proceeds thereof), and (ii) the Estate D&O Claims³ or the proceeds thereof (including proceeds from insurance). All Causes of Action that are not Litigation Trust Assets shall become assets of the Reorganized Debtors.

The Debtors' intent is that each and every Cause of Action, defense, counterclaim, set-off right, and right to prosecute claims against any person, other than those that are released and/or discharged in accordance with Article XI of the Plan, shall be vested either in the Reorganized Debtors or the Litigation Trust, in accordance with the terms of the Plan. This notice is not intended to limit Causes of Action vested in the Reorganized Debtors or the Litigation Trust. This notice is intended to provide notice of known potential Causes of Action.

Attached hereto as Exhibit A is a list of payments made by the Debtors during the ninety (90) days immediately prior to the Petition Date. Attached hereto as Exhibit B is a list of executives whose employment was terminated during the one (1) year immediately prior to the Petition Date and who may have received some form of severance or cash payment from the Debtors. Some of the transfers listed in Exhibit A and/or Exhibit B may be avoidable as preferential transfers pursuant to section 547 of the Bankruptcy Code and/or as fraudulent transfers pursuant to sections 544 or 548 of the Bankruptcy Code and applicable nonbankruptcy law.

³ The Estate D&O Claims are the purported claims against the Debtors' current and former directors and officers alleged by the Committee in the *Motion of the Official Committee of Unsecured Creditors for Authority to Commence Certain Actions on Behalf of and for the Benefit of the Debtors' Estates* [Docket No. 875].

The Debtors are also preserving any and all rights to indemnification to which the Debtors are entitled.
